The Nomination form along with the extracts of the relevant Rules and Regulations of the Association regarding the election and the lists of the life members eligible to contest and vote are enclosed. (See the attachment) It is also available on Website. www.aicp.in

As per the Rules of the Association only the life members who have completed <u>three</u> years as life members as on <u>31st December</u>, <u>2022</u> and have minimum one year of remaining service are <u>alone</u> eligible to <u>contest.</u>

Similarly, the members with a standing of at least one year membership of the Association as on 31st December, 2022 and whose membership is valid and who have not retired from regular service on the date of election and are present in the General Body Meeting / Business Session of the Conference are alone eligible to vote.

The members of the Executive Committee and the Board of Trustees <u>are eligible to contest</u> the election provided they are in regular service on the day of election.

The eligible members may send their nomination forms duly filled in to the President, Association of Indian College Principals, <u>at</u> the following address so as to reach him on or before <u>1st Feb.</u>, <u>2023</u>. Notes:

- 1. The term of the Office Bearers and the Executive Committee members is three years.
- 2. The members proposing and seconding the contestants must have at least one year standing membership as <u>on</u> 31.12.2022 and whose membership is valid and who have not retired from regular service on the date of election.
- 3. <u>The present Executive Committee members, including the Trustees can propose and second the contestants.</u>
- 4. The retired Principals can attend the conference, but are not eligible to vote and contest.

Extracts from the AICP Rules & Regulations relating to the Election.

Rule 2. EXECUTIVE COMMITTEE:

- 2.1 The Association shall be managed by an Executive Committee. The Executive Committee shall consist of not more than 40 members, as stated below:-
 - 1. President One
 - 2. Vice President One
 - 3. Secretary General One
 - 4. Joint Secretary Cum Treasurer One
 - 5. Zonal Vice President Four
 - 6. Zonal Jt. Secretaries Four
 - 7. One member from each state and Union territory of India from amongst the members of the Association.
- 2.2 The President, the Vice-President, the Secretary, the Jt. Secretary Cum Treasurer and one member from each state and union territory of India shall be elected at the General Body meeting out of these, four office bearers and the members, thus elected, shall nominate 4 Zonal Presidents and 4 Zonal Jt. Secretaries at their first meeting, which shall be held immediately on the same day, after the election.
- 2.3 The members of the Executive Committee shall have a term of three years. However, the present First Executive Committee constituted at the time of the registration of the Association shall have a term of FIVE years, so that the Committee can take necessary steps, give direction and undertake concrete work to lay the foundation of the Association.
- 2.4 A member of the Executive Committee shall not have more than two consecutive term.
- 12 Membership : Membership of the Association is offered as follows

Eligibility: Any Principal of a College affiliated to a statutory / deemed university is eligible for membership of the Association

Categories of Membership:

- 1. Ordinary Membership: Rs. 500-00 (Five Hundred Only) per annum.
- 2. Life Membership: Rs. 3000-00 (Rupees Three Thousand only Life Time)

Principal of a College shall be a member of the Association so long as he is in the service as Principal. The ordinary membership is valid for the calender year and it is to be renewed every year.

- Cancellation of membership: A member shall cease to be a member of the Association on the following grounds:
 - a. As and when a member resigns from his membership.
 - b. If a member fails to pay membership subscription (incase of ordinary membership) every year, on or before 31st December, such a member can get renewed his membership by paying the arrears of subscription.
 - c. A member is liable to be suspended or expelled if he or she is found wilfully engaging in activities prejudicial to the interests of the Association. However, such a member should be served with a notice in writing giving thirty days time to explain his/her conduct. If the explanation is not satisfactory, the executive committee may suspend or expd the member through a decision supported by a majority of the members present at its meeting.
- Only the life members with atleast three years standing as Life members of the Association shall be eligible to contest for any post or membership of the Executive committee. This provision shall apply to the elections to be held in the year 2003 and thereafter.
- To contest election for the post of President, Vice President, Secretary, Jt Secretary-cum Treasurer or membership of the executive committee, a member should file a nomination form proposed by two members and seconded by two members separately provided the proposers and the seconders had atleast one year's standing as members of the Association, prior to the date of election.
